## Terms and Conditions Exclusive Motorcycle Financing with AEON Credit (“Campaign”)

### 1.0 CAMPAIGN PERIOD

- 1.1 This Exclusive Motorcycle Financing with AEON Credit Campaign (“**Campaign**”) is organized by AEON Credit Service (M) Berhad (“**AEON Credit**”) and will commence from 23<sup>rd</sup> June 2023 to 23<sup>rd</sup> September 2023, both dates inclusive (“**Campaign Period**”).
- 1.2 By entering and participating in this Campaign, you are deemed to have read, understood and agreed to be bound by all the terms and conditions below (“**Terms and Conditions**”).

### 2.0 ELIGIBILITY
